1. The Tarlac State University, through Regular Agency Fund (RAF) and Special Budget (SB) 2024 intends to apply the sum of **Eleven Million Two Hundred Thirty Thousand Pesos (₱ 11,230,000.00)** to payments under the contracts for the project: **Supply and Delivery of TSU Vehicles, Lot No. 2 & 3**.
3. The project consists of the following lots with their corresponding ABC.

Quotations received in excess of the ABC for shall be automatically rejected at bid opening.

2. The TSU Bids and Award Committee (BAC) now invites technically, legally, and financially capable suppliers for the said project.
3. The Procurement procedure for this requirement is Negotiated Procurement for Two Failed Bidding pursuant to Section 53.1 of 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

The selection of the successful offer shall be based on the best and final offer that will be submitted on the set deadline by the BAC and which would meet the minimum technical specifications required.

4. The interested bidders may obtain further information from the BAC Secretariat at the address given below from November 12, 2024 to November 22, 2024, Tuesday to Friday, at 8:00AM to 5:00PM.
5. The TSU-BAC will hold a Negotiation Meeting on **November 19, 2024 at 2:00 P.M.**, at BAC Conference Room, 3rd Floor, Motorpool and Administration Building, Tarlac State University, Romulo Blvd., San Vicente, Tarlac City, which shall be open to prospective bidders.
6. A complete set of the negotiated procurement documents may be acquired by interested suppliers from the address given below, free of charge.
