**WHEREAS**, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Books (APP 2023) with an Approved Budget for the Contract (ABC) of ₱ 14,865,535.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on July 26, 2023;

**WHEREAS**, in response to the Invitation to Bid, three (3) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) on August 3, 2023;

**WHEREAS**, in the public bidding held at the Business Center Audio Visual Room (TSU-BC AVR) on August 15, 2023, at 2 P.M.:

- (a) Three bidders, namely, C&E Publishing Inc., New Century Books & General Merchandise, and Infopage Education Services Inc. tendered their bids for the aforementioned project,
