**WHEREAS**, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Tokens for the TSU Service Awards 2022 with an Approved Budget for the Contract (ABC) of ₱ 1,145,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on July 16, 2022;

**WHEREAS**, in response to the Invitation to Bid, no prospective bidder participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) on July 26, 2022;

**WHEREAS**, in the public bidding held at the TSU-BC AVR on August 9, 2022, at 2:00 P.M.:

- (a) one bidder, namely, Laricel's Jewelry, tendered a bid for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bid of the lone bidder and found it to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and was rated "passed",
- (c) the BAC resolved to declare Laricel's Jewelry, as the bidder with the Single Calculated Bid with the amount of 1,119,500.00,
- (d) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the and Single Calculated Bid;

**WHEREAS**, in the Post-Qualification Evaluation Conference held via Zoom on August 24, 2022:

- (a) the TWG for Financial and Legal Aspects reported that the Single Calculated Bid was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the Single Calculated Bid was responsive to the technical requirements for the project as prescribed in the Bidding Documents,
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the Single Calculated Bid as responsive;

**THEREFORE**, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

(a) to declare Laricel's Jewelry, as the bidder with the Single Calculated and Responsive Bid (SCRB), with the bid price of One Million One Hundred Nineteen Thousand Five Hundred Pesos (1,119,500.00), and

(b) to recommend to the President the Award of Contract for the project, Supply and Delivery of Tokens for the TSU Service Awards 2022 to Laricel's Jewelry.
